Measures 17-20 of the Sonata from Die Bankelsangerlieder, measures 1-6. The score is in G minor (three flats) and 3/4 time. Measures 17 and 18 feature a rapid sixteenth-note melody in the first two staves, with a trill (tr) on the second staff in measure 18. Measures 19 and 20 continue the melody, with a trill (tr) on the second staff in measure 20. The lower staves (3-6) provide a harmonic accompaniment with various rhythmic patterns.
