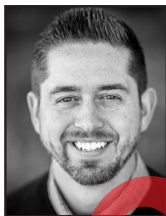
NOTES TO CONDUCTOR

This programmatic work was written with the young band at the front of mind, with careful attention to range, rhythmic challenge, and length of phrase. A consistent percussion presence throughout will be helpful in ensuring ensemble vertical alignment. Additionally, considerations have been taken to ensure playability with a limited instrumentation. Take full advantage of the written dynamic contrasts to create maximum intensity!
